- Do not use over painted surfaces.
- Do not mix with other chemicals.

PRODUCT APPLICATION

Before product use, take appropriate safety precautions. Refer to the Safety Data Sheet for details.

Always test first in several inconspicuous areas to confirm desired results.

1. Spray directly on the area to be cleaned from 5" to 7" (12.5 to 17.5 cm) away.
2. Scrub the surface using a brush, white nylon pad, sponge or cloth.
3. Wipe dry using a soft cloth, microfiber cloth or sponge.
4. Use clean water to rinse all surfaces that come into direct contact with food.
5. In the case of tough dirt, allow the product to stand for several minutes before scrubbing.

Close container tightly after each use. Store in original container only. Store between temperatures of 35°F to 90°F (2°C to 32°C). Do not allow to freeze.
